- I understand that the COVID-19 vaccine MAY require multiple doses depending on the manufacturer and additional doses if indicated. If this is NOT my 1st dose, I will bring my vaccine card with me to be completed.
- I agree to stay in the vaccine administration area for fifteen (15) minutes or longer if indicated by the vaccine administrator after receiving my 1st dose of vaccine to ensure that no immediate adverse reactions occur.
- I understand that I will be receiving the vaccination at no cost to me.
- If insured, **please bring in your prescription and medical insurance cards** for your vaccine appointment. I authorize the pharmacy to bill my insurance on my behalf for the immunization – understanding I will not incur any costs.
